In support of strengthening student academic achievement, **Albert M. **DESCRIPTION OF HOW THE SCHOOL WILL IMPLEMENT

**Section A: JOINTLY DEVELOPED**

**Albert M. Greenfield School** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

- **The Annual Title I meeting will be held in the Fall and will discuss the Title I requirements, parent policies, the schoolwide plan, academic standards, assessments, curriculum, how to monitor your child’s progress and working with educators. All families will be encouraged to attend.**
  - **Regularly scheduled Open house meetings (fall and spring) and Evening Meetings (TBA), monthly coffee and conversation with the Principal will continue to address these and other topics regarding school assessments, academic strategies and support, special education and legal rights, among others.**

**Section H: BUILDING CAPACITY OF SCHOOL STAFF**

Albert M. Greenfield School will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

- **Staff development at regularly scheduled dates throughout the academic year. This will begin with staff orientation in September and continue at staff PD on half days and professional development days throughout the year.**
- **At least one staff development will address best practices for communicating with parents and working with parents as equal partners. The results from parent surveys will inform the professional development.**

Albert M. Greenfield School will provide other reasonable support for parent and family engagement activities under Section 1116 as parents may request by:

- **Provide workshops to parents on supporting student achievement and parent engagement.**
- **Parents can request additional support by contact school leadership team**
